- 3. Payment of a Pet Fee of \$200.00 is required for the first pet. The fee for each additional pet will be \$100.00. Pet Fees are non-refundable. Tenant acknowledges that the amount of the Pet Fee is reasonable.
- 4. Only the pet(s) listed and described below are authorized under this agreement. Additional or other pet(s) must be approved by the Agent before they are allowed on the property. This includes pet sitting, visitors, or guests with pet(s) regardless of length of stay.
- 5. Pet(s) will not cause: danger, damage, nuisance, noise, health hazard, or soil the unit, premises, grounds, common areas, walks, parking areas, landscaping or gardens. Tenant agrees to clean up after pet(s) and agrees to accept full responsibility and liability for any damage, injury, or actions arising from or caused by pet(s). Tenant must remove any pet(s) from the premises, even if previously permitted, if in Agent's opinion the pet(s) constitutes a nuisance or creates a disturbance or is otherwise undesirable.
- 6. Tenant agrees to register the pet(s) in accordance with local laws and requirements. Tenant agrees to immunize the pet(s) in accordance with local laws and requirements.
- 7. The Pet Application completed by Tenant is attached hereto and made a part of this Pet Agreement. Tenant acknowledges and understands that a decision to permit Tenant to keep the pet listed and described below is based in substantial part on the accuracy and truthfulness of Tenant's answers to the questions on the Pet Application, and Tenant represents and warrants that said answers are true and accurate.
- 8. Dogs and cats must be controlled at all times and must be kept on a short leash while in common areas. Excessive barking is considered a nuisance and will not be tolerated. Proper disposal of cat litter, securely bagged, will be done on a frequent basis. Odors arising from cat litter will not be tolerated.
- 9. Birds will be properly caged. Seeds and droppings will be shielded or caught to prevent accumulation and/or damage to carpeting/floors.
- 10. Aquariums will not leak and will be cleaned regularly to prevent foul water and/or odors.
- 11. If the pet(s) is/are a dog(s), Tenant understands and acknowledges that as a condition of having such dog(s), Tenant will be required to purchase and maintain a renters' insurance policy as per the Rental Contract, and that such insurance shall provide coverage for any injury to person or damage to property caused by any such dog(s).
